9. PUBLIC HEARINGS

1) Tax Exemption To Certain Qualified Persons 65 Years of Age or Older

WHEREAS, New York State Real Property Tax Law ("RPTL") § 467 provides that a public school district may grant a partial exemption from taxation for real property which is owned by certain qualified persons with limited income who are aged 65 and over; and

WHEREAS, in accordance with RPTL § 467, the Board of Education of the Hauppauge Union Free School District (the "District") previously adopted a resolution providing for a tax exemption to certain qualified persons 65 years of age or over to the extent of 50% of the assessed valuation thereof; and

WHEREAS, RPTL § 467 provides for a new definition of income for exemption purposes for qualifying Persons with aged 65 and over; and

WHEREAS, RPTL § 467 allows school districts the option of adjusting the income definition further by adoption of a resolution after a public hearing; and

WHEREAS, a public hearing was held in accordance with the applicable provisions of RPTL§ 467 on February 27, 2024.

NOW, THEREFORE, BE IT RESOLVED, with respect to the calculation of income for the purposes of the tax exemption for Persons Aged 65 and Over with Limited Income, income, which already encompasses pensions included in federal adjusted gross income (FAGI), will also consist of any distributions received from an individual retirement account or individual retirement annuity that were included in FAGI.

BE IT FURTHER RESOLVED that the District Clerk of the Board of Education of the District is hereby authorized and directed to transmit a copy of this resolution to the Assessors of the Towns upon adoption.

2) Tax Exemption to Certain Qualified Persons with Disabilities

WHEREAS, New York State Real Property Tax Law ("RPTL") § 459-c provides that a public school district may grant a partial exemption from taxation for real property which is owned by certain qualified persons with limited income and disabilities; and

WHEREAS, in accordance with RPTL § 459-c, the Board of Education of the Hauppauge Union Free School District (the "District") previously adopted a resolution providing for a tax exemption to certain qualified persons with disabilities to the extent of 50% of the assessed valuation thereof; and

WHEREAS, RPTL § 459-c provides for a new definition of income for exemption purposes for qualifying persons with disabilities and limited income; and

WHEREAS, RPTL § 459-c allows school districts the option of adjusting the income definition by adoption of a resolution after a public hearing; and

WHEREAS, a public hearing was held in accordance with the applicable provisions of RPTL § 459-c on February 27, 2024.

NOW THEREFORE BE IT RESOLVED, with respect to the calculation of income for the purposes of the tax exemption for Persons with Disabilities and Limited Income, income, which already encompasses pensions included in the federal adjusted gross income (FAGI), will also include of any distributions received from an individual retirement account or individual retirement annuity that were included in FAGI.

BE IT FURTHER RESOLVED that the District Clerk is hereby authorized and directed to transmit a copy of this resolution to the Assessors of the Towns upon adoption.
